The Army IG System

IGs serve their commanders and organizations through four basic functions:

- Inspections
- Assistance
- Investigations
- Teaching and Training

IGs base their fact-finding activities upon standards such as laws, DOD Directives, Army Regulations, policies.

Who Can Submit an IG Complaint?

- > Anyone (must be an Army related issue)
 - Communication with the Inspector General is a **Protected**Communication and no one ought to restrict anyone from speaking with the IG.



Things to "Consider"

- Use your chain of command!
- ➤ IGs do not order **resolution**, they recommend to you or your commander
- ➤ IGs are **fact finders** not fault finders
- Resolution is based on facts only and not hearsay

- Be prepared to take "No" for an answer
- Be honest
- Be sure you have a problem, "not just a peeve"
- Don't expect instant action

What gets Soldiers into trouble?

Abuse of Authority or Position

- > Failure to investigate
- > Failure to take corrective actions
- > Unlawful command influence
- ➤ Barracks and command visits to residence (on and off base) unless for safety reasons.
- ➤ Not Providing Family Support (AR 608-99)

Improper Personnel Actions

- > Failure to provide due process
- Reprisal (I Corps Policy Ltr #7)
- > Performance evaluations, Redress IAW AR 623-3
- > Failure to process DA 4187 and DA 31

Personal Misconduct

- Profile violation
- Sexual misconduct (Redress with SHARP V.A)
- ➤ Abusive profane language
- ➤ Discrimination (Redress any Discrimination of Race, Gender, Sexual orientation, or Religion to your EO Representative.
