MEMORANDUM FOR All Groups using the Family Resource Center

SUBJECT: Child Care Procedures at the Family Resource Center

1. The following are the child care procedures for the Family Resource Center (FRC).

2. Groups that use the FRC for meetings/functions and are scheduled to use the child care room must have certified child care providers at all times. Child care options are as follows:

- Kids-On-Site (KOS) provides equipment, materials, and trained staff from Child, Youth & School Services (CYSS). Approximate cost is \$32.00 per hour per caregiver (subject to change), which include a 30 minute setup time and a 30 minute breakdown. A minimum of two caregivers is required.
- Volunteer Child Care in Unit Settings (VCCUS) provides equipment and required training. Infant/child CPR and first aid is a pre-requisite to the training. Child care may be provided by Soldiers and/or Family members. This training is approximately 4 hours. Contact CYSS at (253) 966-5996 for training availability.
- Direct supervision of each child is required by the parent(s) in their meeting room. Children are not allowed in the copy room or kitchen due to equipment and child safety.

3. Private babysitters and Family Child Care (FCC) providers are **not authorized** to provide child care in the FRC. Child care must be provided by KOS, VCCUS or direct supervision from parents.

4. All participants attending meetings/functions at the FRC must remain on-site while their children are in the building.

The playroom is available during a scheduled FRG event, project, meeting, or training. FRGs have a variety of options for child care on-site. Included in this matrix are also options that may be available at alternative sites. Shared Caregivers	FRGs provide names of their VCCUS trained care- givers to other unit child care coordinators, keep the names on file and make arrangements for sharing care within their own unit or among other units.
