## COVID-19

- COVID-19 Vaccinations (COVAX) hotline: (253) 968-4744.
- Madigan COVID Testing Tent is across from the Madigan ER. It is open 6 a.m. to 2 p.m., Mon Sat Closed Sundays and Federal Holidays.
- Madigan is testing ALL symptomatic personnel (Active Duty SMs, Beneficiaries and DoD Civilians/Contractors). Madigan will
  continue to test asymptomatic individuals that are 1) scheduled for a procedure/ surgery, 2) scheduled for official DoD travel
  that requires testing, and 3) needing a test for return to school purposes. All must have their DOD ID number (including
  children) when presenting for a test.
  - Units are encouraged to arrange for any deployment related testing within their unit footprint. IAW FRAGO 24 to I Corps OPORD 411-20, an O6 signed memo is required to receive a 'rapid' PCR. Without the signed O6 memo testing will be conducted via standard PCR.
- Masks are now optional throughout the area and on JBLM. However, masks will continue to be required indoors at healthcare (including dental clinics) facilities IAW CDC guidance.
- DoD personnel at JBLM will follow Blue Hash protocols for Pierce County; DoD personnel at YTC will follow Blue Hash protocols for Yakima County.

#### Joint Base Lewis-McChord

- Madigan urgently needs blood donations due to COVID-19 positive restrictions on normal supply sources. Individuals can

- Country entry requirements (vaccination/testing) can be found at the top of the DoD Foreign Clearance Guide (FCG) https://www.fcg.pentagon.mil/fcg.cfm
- <u>Isolation and Quarantine Guidance</u> can be found in the JBLM COVID-19 DSM 2023\_02\_01. Service members in the workplace must test at least once after 5 full days following exposure.

These CDC COVID-19 Community Levels will be updated in the Blue Hash as needed. IAW CDC and DoD guidance, implement the following procedures based upon current CDC community levels:
  - When CDC COVID-19 Community Level for Pierce/Yakima County rises to HIGH—indoor masking is required for all personnel (vaccinated and unvaccinated).
  - When CDC COVID-19 Community Level for Pierce/Yakima County is **MEDIUM or LOW**—indoor mask wearing **is not required**.
  - Masking while on DoD conveyances (e.g., aircraft, buses, and GOVs) is no longer required, but recommended when more than one person is present.
  - Updated DoD guidance states that close contacts identified through contact tracing or through exposure must wear a mask around others while indoors for 10 days, even if mask wearing is not otherwise required by Community Levels noted above.
  - NOTE: Updated masking guidance does not apply to Madigan or other MTFs. Regardless of Community Level, mask wear continues to be required when presenting for medical care. All personnel can choose to continue masking based upon their individual preference.
  - o Current Pierce and Yakima County COVID-19 Community Levels are updated by the CDC weekly
  - All facilities operate at 100% capacity regardless of HPCON.

Although not mandatory, DoD strongly recommends personnel remain "up-to-date" with all CDC recommended boosters.


#### **Guidance for events:**

### 62d Airlift Wing (USAF)



Current DoD COVID guidance eliminated a quarantine for close contacts, though personnel are still advised to wear a mask for 10 days post exposure and obtain a PCR COVID test on Day 5 regardless of symptoms.
