

## Recreating on Department of Defense Lands

The principal use of Department of Defense (DOD) lands and waters is to support mission related activities; all other land uses are subordinate. JBLM lands and waters are available for non-military purposes in accordance with Army Regulation 200-1 (Environmental Protection and Enhancement), Integrated Natural Resources Management Plan (INRMP), Sikes Act, and Army directives and policies when compatible with the military mission, installation safety and security, ecosystem sustainability, natural resources management, and fiscal responsibility.



Mission-related activities always take priority on Joint Base Lewis-McChord. Therefore, possession of a state hunting or fishing license, a Federal Duck Stamp, or an installation recreation permit does not guarantee access to JBLM lands.

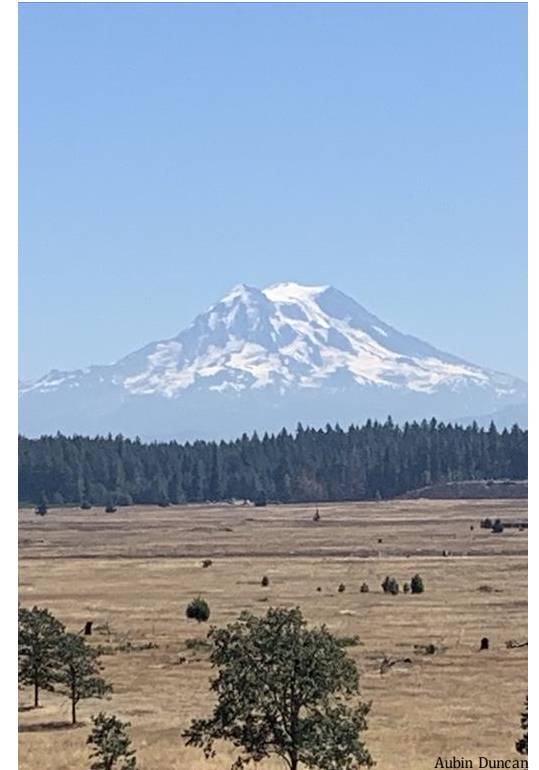

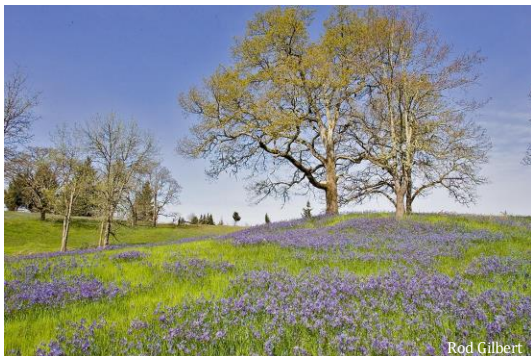
