- 1.) **AUTHORIZED USERS:** Use of the JBLM Resale Lots is restricted to active duty assigned to JBLM and their immediate family members, retired military and DOD civilian employees. All users must have valid ID Card.
- 2.) **DEFINITION OF POV:** For the purpose of using the JBLM Resale Lots, POCs are defined as privately owned non-commercial trucks, cars, boats, trailers, motorcycles, off-road vehicles and motor homes.
- 3.) **AUTHORIZED POVS:** POVs parked on the JBLM Resale Lots **MUST BE PROPERLY INSURED AND REGISTERED WITH THE Provost Marshal Office** following FL Supplement I AR 190-5. All vehicles, boats, trailers, motor homes, and motorcycles must display a valid state license and/or installation stickers. Vehicles not in compliance will be removed immediately from the JBLM Resale Lot at the owner's expense. **NO NOTIFICATION WILL BE GIVEN PRIOR TO REMOVAL.** It is the owner's responsibility to ensure compliance with installation regulations and state laws.
- 4.) **UNAUTHORIZED POVS:** POVs of personnel not authorized to use JBLM Resale Lots or those not properly registered at the Northwest Adventure Center that are found on display will be removed from the area at the owner's expense. **NO NOTIFICATION WILL BE GIVEN PRIOR TO REMOVAL.**
- 5.) **PROCEDURES FOR USE:**
 - a. Authorized personnel desiring to use the JBLM Resale Lots will report to the Northwest Adventure Center, 8050 NCO Beach Road at JBLM North, with the appropriate state registration, proof of insurance, post tag number (to include expiration date) and valid DOD ID Card. Vehicle owners displaying proper documentation will be issued a JBLM Resale Lot Permit. Space will be allocated on a first-come, first-served basis. No permit will be issued if no space is available.
 - b. Upon issue of a permit, the user will park his/her vehicle in the space assigned. Permits will be prominently displayed on the windshield, or in the case of trailers and boats, permits will be attached in the area of the rear license plate.
 - c. Prior to 9 a.m. on the day that the permit expires, the vehicle owner will remove his/her vehicle. If the vehicle is not removed, it will be deemed abandoned and will be removed at the owner's expense. **NO PRIOR NOTIFICATION WILL BE GIVEN.**
- 6.) **RENTAL WEEK:** The rental week begins at 9 a.m. the day it is registered and ends at 8 a.m. one week after the day of rental. Space reservation is limited to 3 weeks maximum and 1 week minimum. For customer convenience, space registration fees may be paid in advance, but there will be **NO REFUNDS** if the vehicle is removed or sold prior to the expiration date of the space rental.
- 7.) **REGISTRATION HOURS:** Monday, Tuesday, and Thursday – Saturday from 0900 to 1730 at Northwest Adventure Center (8050 NCO Beach Road, Lewis North, JBLM, 98433).
- 8.) **LIABILITY:** The JBLM Family & MWR fund is **NOT** liable for any damage or any loss for any reason to any vehicle in JBLM Resale Lots. The owner is responsible to ensure all property is removed from the vehicle and that the vehicle is properly secured. The Northwest Adventure Center, DFMWR, the Army, the Air Force, the United States Government and federal employees are not responsible for POVs or any damage to a POV while it is parked or moving in the JBLM Resale Lot. The POV owner is responsible for all transactions between themselves and any potential buyer.
