We assess every deployment, every country. Many have been postponed or outright cancelled based upon current conditions in that country, along with what we're facing back here. Fall and future deployments are being assessed right now to ensure we can conduct a deployment safely.

5 Any word on the FRAGO 9 HQDA? (Impacts OCONUS PCS and deployments)

This is a recent FRAGO that could place additional measures prior to PCS or other movement. It has not yet come down through FORSCOM, so we are awaiting decisions from other senior leaders before we push out information on it. Expect updates at the next Town Hall.

Are single Soldiers and dual military going to be able to work from home to assist kids with online schooling?

The conditions for each Soldier and their Families can be different. We defer to the Unit Commanders and leaders down to the smallest unit to figure out specific requirements and how to help Soldiers. Overall, everyone is committed to the defense of the Nation and we still need Soldiers to be there doing their jobs to maintain readiness and maintain mission. That's a balance we will have to draw, but we will look to the unit leaders to make those individual decisions based upon individual conditions.

Why is everyone taking off their masks when talking? You can talk with masks on.

They are currently social distanced at this time, and at least 6 ft. of space is between the speaker and the rest of the staff. Additionally, we remove masks for the hearing impaired that may read lips.

Would it be possible if briefers could refer to our members as Service members, not just Soldiers in hopes that our joint services know they are included with these opportunities and resources?

Good point! We'll remind our briefers ahead of time for our next event. Thank you for the reminder that the services on base are available to all our Service members and military families.

#### MWR: School Services & CYS

CYS is unable to register new children to JBLM without a physical completed in the last year. We are unable to get physicals in the Madigan Peds Clinic at this time for children over the age of 10 years old. Our children who had Spring and Summer birthdays are way behind on their Well Child exams

CYS is aware of the difficulty in scheduling/unavailability of appointments at this time. There is currently a 60-day extension on renewals of some health assessments. However, for a new registration, this is different. Please call Parent Central Services for more information, 253-966-2977

As the decisions are being made for schools to begin virtually, what is the justification for increasing school aged care capacity instead of just opening the schools? Are daycare centers safer than classroom settings? Will CYS dedicate time to complete school work throughout the day?

School and childcare safety protocols are not the same. Schools and off-base childcare follow state and local guidance. On-base childcare through CYS follows CDC and Preventative Med guidance. Some things will look different, but everyone is taking every precaution to keep your children safe. How is the Splash Park open with Social Distancing in effect? That place was packed yesterday...

We encourage physical distancing at all of our locations. Parents may choose not to visit, or visit at less busy times.

Can the schools be used by SAC to offer more space for Families who are single, dual military, dual working, etc? Right now, JBLM North only has 20 slots and that doesn't seem possible. Please consider using the schools to allow more slots while practicing social distancing.

MWR is currently assessing the situation for expanding school-age care, and that's one of the options we're looking at. (There are 100+ spaces available at Lewis North SAC, but they are full.)

Why is the daycare still charging Solders for a full month of child care, but sending kids home for 10 days if they have a runny nose?

Sending home for symptoms is part of the safety protocol currently in place. If an absence due to illness extends beyond 10 days, the situation will be evaluated on a case-by-case basis for any kind of refund.

6 Will the school age centers be staffed so the children can do their work at the center?

Educating children is the responsibility of the school district; however, during these unprecedented times, CYS will partner with you and your child to ensure that your child's continued education is facilitated in a safe and healthy environment conducive to learning. CYS staffers will do their best to facilitate your child's learning log-in (at the right time) and technical support.

What is the best way to request the earliest login for a child? It would be much appreciated if children with working parents can get an early login so they can go to work afterward. Would I just talk to the teacher?

Right now, we don't know about schedules. All children in childcare right now have working parents (based on DOD Priority List), so we've heard your request. There is another Schools/CYS town hall 11 a.m. Aug. 19 at our Facebook page (<a href="https://jblm.armymwr.com">https://jblm.armymwr.com</a>), and we hope to have more information from the districts at that time. JBLM families attend 20+ school districts (there are 13 heavily impacted), but with on-base schools being part of CPSD, we understand the importance of this question. Good luck and stay tuned for more.

Can we remove the 2 week termination letter to remove your kids from daycare? I am still paying, but I don't feel safe sending my kids to care at this time. I would rather someone who needs the slots take them.

If you are a current JBLM CARES Patient you would want to identify your concerns with your therapist, so the current treatment plan can be adjusted if needed. # Will EMFP be able to assist families in adjusting their children's IEP for digital learning environment?

We recommend scheduling an initial consult if you are not currently working with a Systems Navigator or to reach back to your Systems Navigator if you have one you have been working with. We would need to review your current IEP or 504 which was likely done prior to a virtual learning environment. If you had a continuous learning plan (which may have occurred with an IEP) for the crisis virtual learning experience in the Spring, we would like to find out from you what your child's experience was during that time so that we can develop key discussion points for correspondence with or to reconvene a virtual IEP or 504 meeting.

#### 4 Are there resources available to assist in tutoring children with IEP's on base?

The Department of Defense offers the following resource to Service Members from all branches of service. Tutor.com (https://military.tutor.com/home) has 24/7 assistance online for all grade and developmental levels. This is a free service for the military that is provided by certified teachers and covers all subjects.

For example if your child is in fourth grade, but has an IEP for reading and is reading on a second grade level. You could identify to the tutor where they are at in the common core curriculum. This would be identified at the top of the IEP goals as a code that corresponds to the common core curriculum standard.

Other potential options would be provided through the school district or the school age center.

### Madigan

Nobody is cleaning the containers/send buttons at the Madigan Drive-through Pharmacy after each use. This is a high traffic / high use location

After each delivery, those containers are decontaminated before another patient's medication is put into them and they are shipped back out.

As for the buttons, they are not decontaminated (similar to ATMs or such out in the community). We recommend when visiting the Patient site, and when you are out and about in general, you wear your face mask to prevent touching your face or other items after, and have hand sanitizer with you and use it after touching the equipment. The risk of contracting the virus is very low from touching these types of things, but employing these good protection measures will help keep you safe and healthy.

We are unable to make Well Child exams for our children over the age of 10 years old. School physicals & sports physicals will not be completed without an appointment within the last calendar year.

During the COVID-19 pandemic, the MAMC Pediatric Clinic must prioritize the care of newborn infants, well babies, immunizations and ill children. During the pandemic it has been necessary to temporarily alter our appointment booking criteria. Recently, the yearly physicals for children ages 2 and up have been deferred. We are offering immunization appointments for every age. When face to face appointments are available, we prioritize booking for children who have chronic conditions and those behind on immunizations. Parents whom need school paperwork, school physicals, EFMP needs or CYS paperwork completed, should send the paperwork to our clinic through the MHS Genesis Patient Portal. If your child has been seen in our clinic within the last 2 years, we will complete the paperwork and return via the Patient Portal. Parents can book a virtual appointment or speak with one of our experienced nurses on the phone if they have specific concerns about their child. We do offer virtual visits by phone and video. Please reach out to your care team if you have concerns about the care of your child. Thank you for your understanding during these unprecedented times.

#### **Commissary**

There are no cart wipes available at the Main Post Commissary. Also, the mobile hand sanitizer stands are often empty. I have asked about both and was told "the carts are being sanitized."

Last week, I watched an employee with no mask on spray the carts — spray hit only superficially and nothing was wiped down.

All carts are sanitized at the end of each evening and between customer uses. The solution used does not need to be wiped down or dried off.
