Prior To Leaving Any Installation

Email a request to the IEP or 504 Case Manager for an amended IEP/504 to include recent progress in the present levels and if, the type of special education i.e. resource, functional academics, life skills for the receiving school.

Arriving to the New School

Email of your IEP Case Manager or 504 Case Manager, the school counselor. Share with the school team what motivates, comforts, and redirects your child.

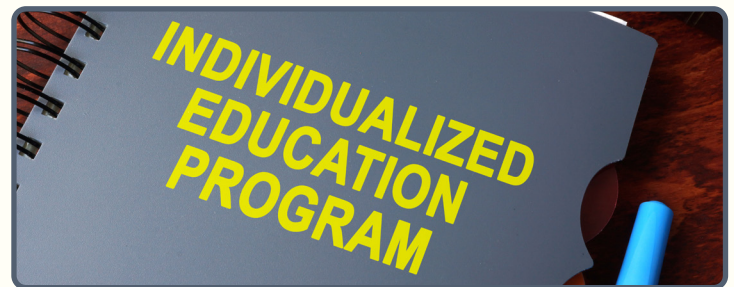
